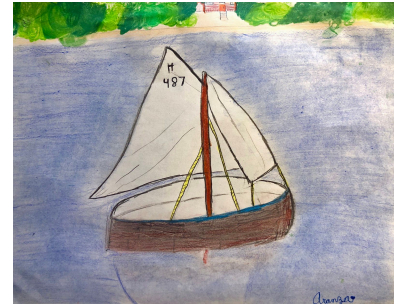

Who Can Participate:

- Any student actively enrolled in First through Sixth Grade in any public school, private school, or home study program in Central Ohio (includes Franklin, Delaware, Licking, Union, Pickaway, Madison, Knox, Morrow, Marion, & Fairfield County)
- Student must be a U.S. citizen or U.S. national

How to Participate (Entry Guidelines):

Students can participate by submitting a piece of artwork based on the **theme of “Outdoor Adventure!”**

To be eligible, artwork must:

- Follow the theme “**Outdoor Adventure**”;
- Be two-dimensional (but may be created using a variety of materials!);
- Include the colors **blue** and **green** (but may have other accent colors within the image!);
- Be the student’s own, original work (sourced material must be documented) completed only by the student;
- Fit within an 8”x10” aspect ratio; and landscape or portrait
- Be signed on the front by the student.

To submit an Entry, upload a high-quality photo of the student’s artwork including the student’s name, age, and school to NSAC’s

Limit one (1) entry per student.

Submission Deadline: November 2nd, 2018 at 11:59 PM EST.

Prizes:

NSAC and A&F will select one (1) winner from each grade. Each of the six (6) winners will:

- Have their **Entry framed and displayed in the Abercrombie Kids store located in the Easton Town Center** (3968 Easton Station space b-112, Columbus, OH 43219); and
- Receive a **\$250 abercrombie kids gift card.**

Winner Selection and Notification:

Artwork will be judged by representatives from the NSAC and A&F using the following criteria:

1. Compliance with the entry guidelines;
2. Commitment to the Contest theme (“**Outdoor Adventure**”);
3. Artistic level; and
4. Uniqueness and creativity.

Winners will be notified by email on or around **November 9th, 2018** at the email address entered at the time of Entry submission. The gift card prize may be delivered to the address you entered at the time of Entry submission, otherwise each winner will pick the gift card up in the store . Winners are responsible for all federal, state, and local taxes and fees which may be associated with this gift card prize.

Disqualification:

Please note, certain subjects are considered unacceptable for the Contest, and Entries depicting these subjects will be disqualified from the judging process. The subjects include, but are not necessarily limited to:

- Any subject matter that, in the sole judgment of NSAC or A&F, is highly controversial or includes items, symbols, or themes that may represent racism, prejudice, profanity, or are of a lewd nature;
- Subject matter that invades any right of privacy, is defamatory, libelous or slanderous, or violates any other right of any person or entity;
- Satanic or violent art; and
- Nudes and inappropriate or suggestive clothing, or a lack thereof.

Grant of Rights:

Applicant grants NSAC and A&F the royalty free, irrevocable, unrestricted, perpetual, worldwide right and license (but not the obligation) to use, edit, modify, reproduce, distribute, publish, and display the Entry, and Applicant’s name, image, likeness, and/or school in connection therewith, for the purposes of marketing and promoting the A&F and/or NSAC brands in any and all media now known or hereafter devised including, without limitation, any digital and/or online uses (e.g., web, social media, paid media), print marketing (e.g., magazines), and point of sale uses (e.g., in-store displays, signage).
